Echostar Communications Corporation ("EchoStar") hereby submits to the Commission certain additional documents that were collected at the request of the Department of Justice ("DOJ") subsequent to the first "sweep" of document production and that are responsive to portions of the Commission's February 4, 2002 Initial Information and Document Request (the "Request") that call for the production of documents.
