STATEMENT CONCERNING SERVICE OF COUNTERPROPOSAL

Cameron Broadcasting, Inc. ("Cameron") hereby submits this Statement concerning the service it has attempted with respect to its Counterproposal, filed July 15, 2002, in the instant proceeding, DA 02-124, released May 24, 2002 (the "NPRM")

1. Cameron's Counterproposal entails the substitution of Channel 277A for Channel 234C2 for radio station KZKE(FM), Seligman, Arizona. As indicated in Attachment M to Cameron's Counterproposal, the licensee of Station KZKE(FM) is aware of and has consented to the proposed substitution.

2. 


