**QWEST CORPORATION'S NOTICE OF UPDATED EXHIBIT A TO
STATEMENT OF GENERALLY AVAILABLE TERMS AND
CONDITIONS**

Qwest Corporation ("Qwest") submits this notice of its update to Exhibit A of Qwest's Statement of Generally Available Terms and Conditions ("SGAT") in the State of Iowa, along with the Amended SGAT Exhibit A itself, which is filed herewith.¹ Qwest respectfully requests that the Iowa Utilities Board ("Board") allow this version of Exhibit A, and specifically those revised rates reflected in Exhibit A, to go into effect pursuant to 47 U.S.C. § 252(f)(3)(B), and acknowledge that the rates reflected on Exhibit A will become effective on a retroactive basis as of June 7, 2002.

DISCUSSION

On May 24, 2002, Qwest filed an amended SGAT with the Board pursuant to Section 252(f) of the Telecommunications Act of 1996 ("Act") that included, among other things, new, lower rates for certain Unbundled Network Elements ("UNEs") and Local Interconnection

Service (“LIS”) elements.² Although Qwest believed that the prior rates established by the Board complied with the Act and the Federal Communications Commission’s (“FCC”) pricing rules, Qwest filed the revised, lower rates to eliminate any question in connection with Qwest’s 271 application for Iowa that the effective rates satisfied the relevant provisions of the competitive checklist.

Qwest filed its 271 application with the FCC on June 13, 2002,³ and the Department of Justice (“DOC”) issued its recommendation for approval on July 23, 2002. As a result of comments filed by the DOJ and CLECs concerning the Iowa prices in the application and, in particular those comments made by AT&T and MCI WorldCom with respect to the prior sale of exchanges in Iowa, Qwest has developed still lower rates to accommodate the removal of the sale of exchanges in the FCC’s synthesis model. Qwest discussed this issue both in its Reply Comments filed with the FCC on July 29, 2002 and in the Reply Declaration of Jerrold L. Thompson appended to the Qwest Reply Comments filing.⁴ Qwest requests that the submitted rates become effective on the same date as when the revised rates were made effective, June 7, 2002.

Qwest will incorporate these new rates into its interconnection agreements. Where a rate in Exhibit A is lower than the rate currently in a CLEC’s interconnection agreement, the lower

rate will be effective retroactive to June 7, 2002. The net effect of this action will be to maintain or reduce wholesale rates in Iowa. In no case will Qwest increase rates to our CLEC customers.

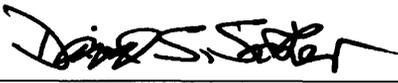
Qwest intends that these new, lower rates remain in effect for its CLEC customers until one of the following occurs: the Board establishes a different rate in a cost docket; we file with and receive the approval from the Board of a mutually acceptable different rate; or a change in applicable law takes place triggering a rate change pursuant to any "change in law" provision of an applicable interconnection agreement.

CONCLUSION

For the foregoing reasons, Qwest respectfully requests that the Board allow this version of Exhibit A to the SGAT to go into effect on a retroactive basis as of June 7, 2002 pursuant to 47 U.S.C. § 252(f)(3).
