**QWEST CORPORATION'S NOTICE OF FILING REVISED EXHIBIT A  
TO THE SGAT**

Qwest Corporation (“Qwest”), by and through its counsel, hereby files a revised Exhibit A to Qwest’s Idaho Statement of Generally Available Terms (SGAT) providing for lower rates for some Unbundled Network Elements (“UNEs”) and Local Interconnection Services (LIS”) elements.

On May 24, 2002, Qwest filed a Third Revised SGAT, including a Revised Exhibit A containing new, lower rates for certain Unbundled Network Elements and LIS elements that

became effective on June 7, 2002<sup>1</sup>. Although Qwest believed its prior rates complied with the Telecommunications Act of 1996 in general and TELRIC in particular, it filed the revised, lower rates to eliminate any question in connection with Qwest's FCC 271 application that its rates satisfied the relevant provisions of the competitive checklist.

Qwest filed its Idaho 271 application along with Colorado, Iowa, Nebraska, and North Dakota with the FCC on June 13, 2002, and the Department of Justice issued its recommendation for approval on July 23, 2002. As a result of comments filed by CLECs concerning the Idaho prices in the application, in particular those made by AT&T and MCI WorldCom with respect to the prior sale of exchanges in Idaho, Qwest has developed still lower rates to reflect the removal of the sale exchanges from the FCC's synthesis model. In addition, Qwest has made a few clarifications in Exhibit A, relating to the application of the Quote Preparation Fee for caged and cageless collocation and the applicability of the Wholesale Discount Rate to the PAL product. Qwest has also modified its price structure for 48 Volt DC Power Usage to be consistent with the structure offered in other Qwest states and with its proposal for the Idaho cost docket. In addition, Qwest has restated the price for the fiber Entrance Facility for collocation to a per fiber rate as contrasted with the per pair rate previously offered. Finally, in response to CLEC requests for a rate associated with collocation augments, Qwest is submitting a rate for this product. Qwest requests that the submitted rates and clarifications become effective on the same date as when the revised rates became effective, i.e., June 7, 2002.

<sup>1</sup> Qwest's filing asked that the Commission allow the rates to become effective on June 7, 2002. Pursuant to the *Commission Final Decision on Qwest Corporation's Compliance with Section 271* served on June 10, 2002, the Commission confirmed that the rates would become effective but used the date of June 10. Qwest did not revise its implementation protocols to delay the effective date and therefore, from a practical standpoint, the effective date remained June 7, 2002.

Qwest will incorporate these submitted rates and clarifications into its Interconnection Agreements. Where a rate in the revised Exhibit A is lower than the rate currently in a CLEC's Interconnection Agreement, the lower rate will be effective prospectively. Customer bills will also be credited back to June 7, 2002. The net effect of this action is to maintain or reduce wholesale rates in Idaho. In no case will the action result in increased rates to Qwest CLEC customers. Qwest's CLEC customers are being notified of these changes.

Qwest intends that these new, lower rates would remain in effect for its CLEC customers until one of the following occurs: the Commission establishes a different rate in a cost docket; Qwest files with and receives the approval from the Commission of a mutually acceptable different rate; or a change in applicable law takes place triggering a rate change pursuant to any "change in law" provision of an applicable interconnection agreement.

Qwest requests that the Commission approve the effective date of these rates on a retroactive basis as of June 7, 2002.
