SUPPLEMENT

M&M Broadcasting, LLC ("M&M"), licensee of Station KADD, Laughlin, Nevada ("M&M") by its counsel, hereby submit this Supplement to its counterproposal in the above-captioned proceeding.¹ M&M filed its counterproposal on August 13, 2001.

In paragraph 14, the counterproposal stated "Channel 228C can be allotted to Logandale at coordinates 34° 55' 40" N, 114° 35' 51" W in compliance with the Commission's spacing rules" and referred to Figure 7 of the attached Engineering Exhibit. The recited coordinates were in error. In fact, the Channel 228C allotment can be made at coordinates 36° 50' 52" N, 114° 28' 37" W. These coordinates were correctly stated in the engineering exhibit at Figure 7.

WHEREFORE, M&M urges the Commission to consider the proper coordinates in connection with their Counterproposal.




