Dear Ms. Dortch:

Qwest hereby responds to a request from the Wireline Competition Bureau for clarification concerning the volumes of manually processed orders for UNE-P, resale and UBL for PO-20 for April to July. Specifically, the volumes reported in Qwest's September 3, 2002 ex parte seemed low to the Bureau.

Qwest found an error in the code used to count the manual service order volumes for April 2002 to June 2002 whereby only service orders eligible for the OP PID measures were counted. This resulted in many features-only orders being excluded from the count. Qwest has fixed this error and has produced corrected volumes (along with data for the month of July 2002). This error in no way impacted the published PO-20 results. Below are the volumes of manually processed LSRs between April and July 2002. The numbers represent all inward line and feature LSRs that were not rejected, did not receive non-fatal error notices, and were manually processed.


