As Hispanic members of Congress, we are writing regarding the proposed merger of Univision Communications Inc. (Univision) and Hispanic Broadcasting Corporation (HBC). These two companies play an important role in serving the needs of the U.S. Hispanic community with their Spanish-language radio and television broadcasts. Both companies have met with our offices to discuss their alliance and to address questions regarding programming, employment and general operating functions of a merged company. Our questions and concerns were answered to our satisfaction.

We have been apprised that Univision and HBC plan to use their mutual expertise to better inform, entertain and educate American Hispanics. The combined company would maintain separate Television and Radio divisions, headquartered in Los Angeles and Dallas respectively, while using synergies to secure new advertising dollars for Hispanic media. Company representatives inform us that the merger would result in increased public service to the fast growing Latino population throughout the United States many of whom we directly represent.

We ask that this transaction receive every consideration consistent with applicable laws and regulations, and that we be informed should issues arise that may be of concern to your Department. Thank you for your kind consideration of this matter.
