



Dear Sirs:

I am submitting this letter of appeal to your department as I have previously appealed to the SLD and my request was denied. I am not satisfied with the decision to deny nor the basis for the decision.

I received a Letter of Acknowledgment written on February 12, 2002, which referred to only one of two FRN's that are listed on the Dickey LaMoure Form 471 Application # 317023 of which I enclosed a hard copy. In the past we have had two FRN's listed on our Form 471. same as we do for Year 5, even listing the same two FRN's every year. I therefore appealed through SLD, and received a denial. This has led me to a second appeal through your department (FCC).

I was told in my letter of denial by the SLD that there was an incomplete application filed (which must have been done by mistake). The incomplete application has the application number 315266. The missing FRN did not refer to this form. My letter of appeal which was written to the SLD referred to Application # 317023 as I was unaware of an "incomplete application form" having been filed. There is a hard copy of this application enclosed. If the hard copy is reviewed, you will see that both FRN's are listed on this application, yet the response to my appeal was that the second FRN is being denied. For the following reasons, I am requesting another appeal:

1. I was unaware of an incomplete application having been filed (315266).

2. ~~Past~~ year's applications for Dickey LaMoure Special Education Unit included the same two FRN's which have previously been approved.
3. The hard copy of Application 317023 is enclosed **and** does have information in Block **5** referring *to* both FRN's.

On the basis of the above reasons. I **am** therefore requesting **an** appeal from your department.

After thorough review and investigation of all relevant facts, the Schools and Libraries Division ("SLD") of the Universal Service Administrative Company ("USAC") has made its decision in regard to your appeal of SLD's Year Five Funding Commitment Decision for the Application Number indicated above. This letter explains the basis of SLD's decision. The date of this letter begins the 60-day time period for appealing this decision to the Federal Communications Commission ("FCC"). If your letter of appeal included more than one Application Number, please note that for each application for which an appeal is submitted, a separate letter is sent.

Funding Request Number: Missing FRN – US Link  
Decision on Appeal: **Denied in full**  
Explanation:

- Your appeal letter stated that a RAL was received on Feb 12, 2002, which referred to only one FRN instead of two FRNs. You have not received any letter informing you that the second FRN has not passed the *MPS*. You completed the form electronically, thus you sent a hard copy of the form along with a letter of appeal.
- SLD records show that you had actually filed two Form 471s. Application Number 3 15266js in an "Incomplete" data entry status, while Application 3 17023 is in a "Complete" data entry status. If the missing FRN was referred to the "Incomplete" application, the form is to be rejected for failing to meet the minimum processing standards since the form was never successfully completed in the system by the deadline of January 17, 2002. Forms that do not meet the *minimum* processing standards are not considered for funding. If the missing FRN was referred to the

“Complete” application, since the funding request of US Link was not included in the original submission. Appeal is therefore denied.

- Your appeal requests additional funds that were not shown in either Form 471 Application Number 315266 or Application Number 317023, in regard to which you are appealing SLD’s funding decision. FCC rules require that funding requests be made on Forms 471. See 47 C.F.R. § 54.504. Funding requests may not be made on appeals of SLD funding commitment decisions. Whether your request can be considered for funding will depend on the date your Form 471 is received and, if it is received after the close of the filing window, whether funds are available. *See* 47 C.F.R. § 54.507(g). Consequently, SLD denies your appeal insofar as it requests funding not requested in the Form 471, which forms the basis of this appeal.

If you believe there is a basis for further examination of your application, you may file **an** appeal with the Federal Communications Commission (FCC) via United States Postal Service: FCC, Office of the Secretary, 445-12<sup>th</sup> Street SW, Washington, DC 20554. If you are submitting your appeal to the FCC by other than United States Postal Service, check the SLD web site for more information. Please reference CC Docket Nos. 96-45 and 97-21 on the first page of your appeal. **The FCC must RECEIVE your appeal WITHIN 60 DAYS OF THE ABOVE DATE ON THIS LETTER for your appeal to be filed in a timely fashion.** Further information and new options for filing **an** appeal directly with the FCC can be found in the “Appeals Procedure” posted in the Reference Area of the SLD web site, [www.sl.universalservice.org](http://www.sl.universalservice.org).


Dear *Sirs*:

1. FRN (Funding Request Number): The FRN is the Funding Request Number that the SLD assigned to each Block 5 funding request that is entered into our data system. 4. Category of Service: This is the type of service for which you have requested discounts from Block 5, Item 11. The categories of services are: Telecommunications Services (Telc Svc); Internet Access (Inet Acc); Internal Connections (Intr Con).
5. Pre-discount Dollar Amount: This is the total annual pre-discount cost for each FRN. This amount is taken from Block 5, Item 23, Column I.
6. Discount Percentage: This is the discount percentage from Block 5, Item 23, Column J.

#### MISSING FRNs


