Dear FCC:

I am writing to appeal the decision by the USAC Schools and Libraries Division regarding Billed Entity Number 11575, Magen David Yeshivah, 471 Application # 231377, FRN's: 587836, 588033, 588115, 589056, 589093, 628895, 629148, 629527, 629838, 630440, 630663, 631231

In a letter dated September 26, 2002, our appeal was denied in full. I am writing to appeal this denial. The original 486 form was denied because it had a date in the lower right-hand corner of April 2000. My appeal was denied because I admitted that this was indeed the form originally submitted.

I am enclosing a copy of the "Form 486 Return Letter" dated 1211412001 which accompanied the returned 486 form, originally submitted to the SLD on 10/22/01. You will note that the stated reason for denial is "The Form 486 submitted *is* not the correct, OMB-approved ECC Form 386, with a date of **April 2000 or July 2001** in the lower right-hand corner of each page." Therefore, the original form should have been accepted, based on this letter.

The denial in effect reduces our approved amount by 40%. I sincerely believe that this decision is not fair. Thank you for reconsidering this matter.
