I will never do business with a telemarketer. If I do business with a firm by my own initiative or even direct mail, I am not giving permission for that firm to telephone me about any new business. They may rightly telephone me only regarding the old business that I initiated in the past. Specifically, a company must honor a do-not-call request even when the customer continues to do business with the entity making the solicitations. I, as the customer, will initiate any future business.
