As you know, pursuant to the "Protective Order" issued on March 29, 2002 (DA 02-734) by the Federal Communications Commission in the above-referenced proceeding, on July 10, 2002 I submitted an "Acknowledgment of Confidentiality" on behalf of Fleischman and Walsh, L.L.P., outside counsel to AOL Time Warner Inc. in this matter.
