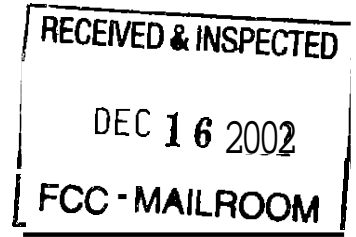

As explained in the documents referenced below, the following evidentiary exhibits, filed with the Federal Communications Commission (hereinafter "FCC") on November 4, 2002 in the above-referenced Proceeding, have either been damaged by the FCC, or have been "misplaced" by the FCC

(2) Part II of the DVD disc copy, containing the last part of the obscene film "More Than A Handful 9" together with obscene pandering Previews shown Before and Previews shown After said film, which collectively are representative of AT&T's entire "In Demand, Pay Per View, Adult's Only" programming, and which demonstrate that AT&T's violations of federal law, as complained of herein, are intentional and willful; and

(3) Exhibit A in Support of the **Ex Parte** Petition of James J. Clancy, consisting of a partial list of AT&T Cable transmissions of obscene programming, showing the date and channel of specifically named obscene movies as transmitted by AT&T's cable TV operation.
