**Re: Applications for Consent to the Transfer of Control of Licenses from Comcast Corporation and AT&T Corp., Transferors, to AT&T Comcast Corporation, Transferee, MB Docket No. 02-70**

Dear Ms. Dortch:

In a Memorandum Opinion and Order (FCC 02-310) released on November 14, 2002, the Commission approved the merger of Comcast Corporation and AT&T Corp.'s broadband business. In doing so, the Commission granted the above-referenced transfer of control applications, including applications to transfer control of certain CARS licenses. This is to notify the Commission that Comcast Corporation and AT&T Corp. consummated their agreement to combine Comcast Corporation and AT&T's broadband business on November 18, 2002. The attached exhibit lists the CARS licenses, including calls signs and application file numbers, for which this notification of consummation is applicable.

The company formed by this merger is named "Comcast Corporation," not AT&T Comcast Corporation, as previously announced.<sup>1</sup> This represents a name change only and does not represent a change in the ownership structure of the merged entity as described in the Applications and Public Interest Statement filed in the above-referenced proceeding on February 28, 2002.


