2. I am presently employed by Kootenai County at the Coeur d'Alene Airport Administrative Secretary in airport operations, and have been since 1993.


3. as a Senior Staff Secretary, and have been since 1999.

6. Upon hearing of the letter during discovery I checked the records and files at the Coeur d'Alene Airport and have not been able to locate the letter.
7. Based upon my observations and research I can state unequivocally that the letter of September 28, 2001, was not received by the Coeur d'Alene Airport.
8. Aside from the copies of the September 28, 2001, letter received through the discovery process, the Coeur d'Alene Airport has never received any notice of Resort Aviation Services, Inc. application for the Unicom license that expired in December of 2001.


