By the Telecommunications Access Policy Division. Wireline Competition Bureau:

1. This Order dismisses the Request for Review filed by Northland Community Schools (Northland), Remer. Minnesota. on behalf of Remer School District No. 118. Renier. Minnesota.' Northland seeks review of a decision issued by the Schools and Libraries Division (SLD) of the Universal Service Administrative Company (Administrator) on October 17, 2001.² The Commission received Northland's Request for Review on December 31, 2001.³

2. For requests seeking review of decisions issued on or after August 13, 2001 under section 54.720(b) of the Commission's rules. any such appeal must be filed with the Commission or SLD within 60 days of the issuance of the decision that the party seeks to have reviewed.⁴ Documents are considered to be filed with the Commission only upon receipt.' Because the


