Dear Ms. Dortch:

On January 22, 2003, Jonathan Blake, Jennifer Johnson, Bob Long and Brian Smith of Covington & Burling and Mark Prak of Brooks, Pierce, McLendon, Humphrey & Leonard, counsel for the Network Affiliated Stations Alliance (“NASA”), met with Mania Baghdadi, Julie Buchanan, Paul Gallant, Marcia Glauberman, Judy Herman, Roger Holberg, Bob Ratcliffe, Debra Sabourin, Royce Sherlock, Roy Stewart and Patrick Webre to discuss the joint comments filed by NASA and the National Association of Broadcasters with respect to the 35% national television ownership cap. At the meeting, NASA representatives discussed the information included in their initial comments in support of the 35% cap, and responded to questions from those in attendance with respect to the positions taken in those comments. In addition, NASA representatives discussed the information submitted by the networks in this proceeding relating to preemptions of network programming by affiliates and O&Os, pointing out that this information was limited in nature and did not sufficiently reflect the impact affiliates have on localism.
