This notice of oral ex parte contact is meant to cover a conference call involving NARUC members and the FCC concerning action in the above-captioned proceeding.


On Thursday, March 13, 2003, from 3:30 to 4:30 pm EST, the persons listed in the paragraph below participated in a conference call with Margaret Egler and Richard Smith of the FCC staff and David Torok, of the FTC staff. Mr. Torok provided an overview of the FTC's scheduled implementation of its Telemarketing Sales Rule and answered questions on State participation in that process. Margaret Egler discussed the FCC's related open docket on a national Do-Not-Call list in the above captioned proceedings. She noted that recent legislation requires the FCC to complete their proceedings by September and encouraged individual states to call with questions and concerns about the implementation process. Several states expressed concern on the call of the impact of funding that the national list might have on state fees to consumers for signing up for state lists or, to telemarketers, for purchasing state lists. Those funds support vigorous enforcement programs in several states. There was also a brief discussion of transition periods and related possible implementation issues.
