Clear Channel Broadcasting Licenses, Inc. ("CCBL") and Capstar TX Limited Partnership ("Capstar") are among the proponents of a Counterproposal filed October 10,2000 in the captioned proceeding. On January 15,2003, CCBL and Capstar filed a pleading withdrawing their interest in the Counterproposal. 


