## GLOBAL CROSSING LTD. AND GC ACQUISITION LIMITED FILE AMENDMENT TO APPLICATION

### IB DOCKET NO. 02-286

**Comment Date:** March 6, 2003

**Reply Date:** March 13, 2003

On February 13, 2003, Global Crossing Ltd. (Debtor-in-Possession) (“Global Crossing”) and GC Acquisition Limited (“New GX” and, with Global Crossing, the “Applicants”) filed an amendment to their August 22, 2002 applications with respect to the international section 214 and submarine cable license file numbers listed below.<sup>1</sup> The February 13, 2003 amendment provides new foreign carrier affiliation information in accordance with sections 1.767(a)(8) and 63.18(i)-(k) of the Commission’s rules, 47 C.F.R. §§ 1.767(a)(8) and 63.18(i)-(k). In particular, the amendment describes ST Telemedia’s acquisition of a controlling stake in PT Indonesian Satellite Corporation (“Indosat”) and Indosat’s subsidiaries. By this notice we are providing an abbreviated comment period on the February 13, 2003 amendment.

<sup>1</sup> The August 22, 2002 applications seek Commission consent to transfer control of Global Crossing’s FCC-licensed subsidiaries from Global Crossing to New GX, and request a declaratory ruling that the proposed indirect ownership interests in Global Crossing North American Networks, Inc. by Hutchison Telecommunications Limited (“Hutchison Telecom”), a Hong Kong company, and Singapore Technologies Telemedia Pte Ltd (“ST Telemedia”), a Singapore company, are in the public interest under section 310(b)(4) of the Communications Act.

if, upon further examination, it is determined to be defective and not in conformance with the Commission's rules or policies.

All filings concerning matters referenced in this Public Notice should refer to **IB Docket No. 02-286** as well as to any specific file numbers of the individual applications or other matters to which the filings pertain.

Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.
