

2.7 Estimated Schedule

The estimated schedule for this effort is 12 months *from* the date of project initiation.

Project Start Date:	July 1, 2002
Project End Date:	June 30, 2003

Work will begin July 1, 2002, given that NETC receives adequate funding for **the project**. The schedule shall be consistent with the completion dates identified by **the** NETC and agreed **to** by IBM. Reasonable effort shall be made by IBM and NETC to keep **the** schedule dates **intact**.

IBM will not be responsible for delays or additional requirements imposed by any government agencies. The IBM will not be responsible for delays caused by delays in project funding, labor disputes, fire, unavoidable casualties, or unforeseen conditions.

2.8 Charges

The Services Charge stated here represents **the** maximum allowable charges for all services that may be provided under this Statement of Work. IBM understands that **the decision** to implement this project **is** contingent upon award to the District of funding under the E-rate program. IBM will not **begin** work **on** this project without **written** notification from NETC **that** funding **has been approved** and that work should begin. If such **notification has** not been received by December **31, 2002**, at **IBM's** option, IBM may terminate **this** Statement of Work or implement an extension of this Statement of Work, **as well** as changes in pricing **or** other terms and conditions as may be required, via **the Project Change Control Procedure** outlined in Appendix A.

Or this amount may **be** extended upon mutual agreement **between** NETC and IBM as defined in **the section titled** Project Change Control Procedure. Should NETC not receive the requested funding for **E-rate 5** or **should** NETC receive only partial funding, IBM will work with NETC to incorporate those **portions** of E-rate 4 funding that can be accomplished **based** upon available funding.

It is understood by NETC and IBM that this SOW and **its** associated pricing **is** based upon **IBM** receiving written **approval** from NETC to proceed with E-rate 5 **no** later than December **30, 2002**. WESTERN STATES CONTRACTING ALLIANCE

BYLAWS

I. NAME

The name of this organization shall be the Western States Contracting Alliance (hereinafter referred to as WSCA).

II. PURPOSE

The purposes of WSCA are to establish the means by which participating states may join together in cooperative multi-State contracting, to ensure the commitment of each participating state, and to provide regular and ongoing assistance to participating states in researching, developing, and administering procurement and contractual specifications and requirements. WSCA maintains a cooperative relationship with the National Association of State Purchasing Officials (NASPO) and may enter into agreements for staff support through NASPO with the Council of State Governments.

III. MISSION AND GOALS

A. Mission Statement

WSCA members will implement multi-state contracting to achieve cost-effective and efficient acquisition of quality products and services, which may include environmental considerations and market development.

B. Goals

1. Maximize cost savings and reduce administrative costs.
2. Standardize specifications and consolidate requirements to encourage product, availability and market competition.
3. Promote and purchase recycled products.
4. Develop specifications that encourage pollution prevention, waste reduction, and energy conservation.

IV. MEMBERSHIP

- A. Membership shall consist of the principal procurement official that heads the state central procurement organization, or designee for that state, from the states of Alaska, Arizona, California, Colorado, Hawaii, Idaho, Minnesota, Montana, Nevada, New Mexico, Oregon, South Dakota, Utah, Washington and Wyoming.

- B. Membership in WSCA is voluntary. Membership may be terminated at any time except when the Member State has signed intent to contract with one or more other states in which case membership shall continue until the term of such contract has ended or the contract has been terminated for cause. Membership may be discontinued by submitting to the WSCA chair-person a letter indicating such intent and signed by the state's principal procurement official.

V. OFFICERS AND DUTIES

- A. Chairperson - The chairperson shall perform the usual duties of a presiding officer. The chairperson shall see that directives and resolutions of the organization are implemented.
- B. Vice-Chairperson - The vice-chairperson shall act in place and stead of the chairperson in the event of absence or unavailability of the chairperson. The vice-chairperson shall complete the chair-person's term of office in the event the chairperson is unable to serve.

For the purpose of this section "unable to serve" is defined as:

- a. Medically incapacitated as evidenced by a doctor's statement;
- b. Voluntary resignation; or
- c. Removal from office by a two-thirds vote of the membership.

VI. ELECTIONS

The chairperson and vice-chairperson shall be elected by a majority of the membership present at the annual meeting and shall serve a two-year term.

VII. MEETINGS

- A. The annual meetings of WSCA will be conducted once a year and held in conjunction with NASPO's annual conference.
- B. Special meetings of WSCA will be conducted on an as-needed basis as determined by the chairperson. Special meetings may be conducted via teleconference.
- C. The chairperson shall notify each member of the date and location of each meeting and agenda items with as much advance notice as is possible.
- D. Quorum - At any meeting of the organization a majority of the members shall constitute a quorum for the transaction of business.
- E. Voting - all members are entitled to one vote each. Proxy voting will be allowed in writing only if submitted to the chairperson in advance of the vote. The chairperson

shall notify each member of matters to be voted on with as much advanced notice as is possible. No official action shall be taken without a vote at a meeting with a quorum present. Except as otherwise provided in the bylaws, a simple majority carries the vote.

VIII. CONTRACTING PROCEDURES

- A. Contracting procedures shall be governed by at least the following WSCA documents as reviewed and approved at each annual meeting
 - a. WSCA bylaws
 - b. Intent to Contract
 - c. Master Contract Document
- B. Participation: Other eligible entities permitted by individual state law or policy may participate in WSCA contracts only with approval of the principal procurement official of the parent state. Non-member States or entities may participate in WSCA contracts with the approval of a majority of the members.

IX. AMENDMENTS TO BY LAWS

- A. Bylaws shall only be amended by a vote of two-thirds of the membership.
- B. Additional memberships to WSCA shall be through written request to the chairperson and shall be approved only through an amendment to the bylaws.
- C. Proposed changes to the bylaws will be distributed to members at least 24 hours prior to a vote.

In the case of wireless Wide Area Network technologies, the same approach applies, except that ~~the~~ actual transmission capability, including transmitter, antenna, and antenna ~~mast~~ or structure, is not eligible as Internal Connections.

✓ Q. What is the disadvantage, if **any**, of applying for **funding** of products or services that may not be eligible?

A. At a ~~minimum~~, requests for ineligible products or Services delay processing, to the detriment of both the applicant and **USAC's** limited resources. Additionally, if the dollar amount of any **funding** request **consists** of 30% or **more** ineligible **products** or **services**, the **request** is **rejected**. (**An** application is divided into **separate Funding Requests**, each of which constitutes a **different funding category**, **different service provider**, or **different location** when the **requests** are site-specific.) **This "30% Rule"** is **used** for processing efficiency and for administration of a **program** for which there is greater demand ~~than there are funds~~ available.

. Q. **Are there any** eligibility requirements **for Service** providers to participate in the Schools and Libraries pmgram?

A. All **service** providers who wish to participate in the Schools and Libraries program must complete **FCC Form 498** and receive a Service Provider Information Number (SPIN). (**See** the next Answer for **instructions on obtaining this form**.)

- Q. Telecommunications **Services** are eligible for discount **only** if they **an** provided by **an** eligible Telecommunications Service provider. What is **an** "eligible Telecommunications Service provider?"

A. An eligible Telecommunications **Services** provider is **an** entity **that** provides telecommunications (transmission **service** between sites, ~~where~~ the user of the **Service** chooses **the communication end points**, **and the** form or **content** of **the user's** information is not **changed**) on a "common carriage basii." "Common **carriage**" means **that** the provider is either recognized by a regulatory authority as a common carrier or holds itself **out** to provide service generally to **the public** for a **fee**. Some **categories** of **service** (such as **cellular**, **paging** and **satellite**) may not be **subject** to regulatory authority.

Further information is available **from** FCC Form 498, the **Service** Provider Information **Form**, and its accompanying **instructions**. **This Form** and the instructions are available for download **from** the SLD Forms section of www.sl.universalsmice.org.

Note that Internet access is not considered to be a telecommunications service, and **may** be provided by entities that **are** not eligible Telecommunications Service providers.
