

PETITION FOR RULEMAKING

To the Chief, Allocations Branch:

Linda A. Davidson ("Petitioner") respectfully requests the Commission initiate a rulemaking proceeding for the purpose of considering amending Section 73.202(b) of the Commission's rules. In support whereof the following is stated:

2. Petitioner proposes the Commission allot FM channel 246C3 to Crested Butte, Colorado as its first commercial FM service. This would require amending Section 73.202(b) of the Commission's rules as follows:

3. Crested Butte is an incorporated Town located in Gunnison County, Colorado. In 2000, the United States Census Bureau estimated Crested Butte had a population of 1,529 persons. Crested Butte has elected town officials, a town hall, fire department, public library, post office, movie theater, over a dozen doctors and dentists, 5 banks, 3 churches, and 33 restaurants. It serves as a regional commerce center for the surrounding area. FM channel 212A is licensed to Crested Butte, which proves it to be a community for allotment purposes.

4. FM channel 246C3 can be assigned to Crested Butte in full compliance with the Commission's minimum distance separation requirements. This is illustrated in the attached spacing study. Coordinates used are N 38:50:42, W 106:54:00 and are located approximately 7 Km SE of the community. This site restriction is necessary to prevent short spacings with stations KSPN, Aspen, CO and KCYN, Moab, UT. Petitioner is confident she can find a suitable transmitter site for this allotment if it is assigned as proposed.

5. Petitioner, or an entity with which she is affiliated, intends to apply for a construction permit to activate channel 246C3 if it is assigned to Crested Butte as proposed. If her application is granted, she shall promptly construct and operate the proposed station.

6. Petitioner hereby verifies and affirms that the statements given in this petition for rulemaking are hers, and are accurate to the best of her knowledge.
