iBiquity Digital Corporation ("iBiquity"), by its attorneys, hereby notifies the Commission, pursuant to Section 1.1206 of the Commission's rules, of a meeting held on May 21, 2003 with Peter Doyle, Edward P. De La Hunt, Ann Gallagher, Charles N. Miller and Mary Beth Murphy of the Media Bureau. iBiquity was represented by Albert Shuldiner, its General Counsel, and the undersigned. During this meeting, iBiquity reviewed with Commission staff the status of its AM IBOC system and the recent concerns raised with regard to AM IBOC audio quality. iBiquity indicated it was analyzing those concerns and hopes to have them resolved in the next several weeks. It also informed the Commission that the AM Nighttime Report will be finished and made publicly available in the very near future.


