

Knox County School District's Funding Commitment Letter is dated December 14, 2001 for Year 4 (July 1, 2001 – June 30, 2002). Form 486 was mailed on March 14, 2002 to P. O. Box 7026, Lawrence, KS 66044-7026 via the US Postal Service which was a mailing option in the guidelines. This was a full 30 days before the 486 deadline. (I am attaching a copy of the application with a hand written mailing date)

I phoned SLD on April 4, 2002 and spoke with Josh who said at this point we should assume our Form 486 was "in the process"

I phoned SLD on July 9, 2002 and spoke with Matt who said he was sure it was "in the process and everything was running slow"

I made several other phone calls to SLD, which I did not document, and the response was basically the same as I received from Josh and Matt. Due to the information given by SLD folks, we certainly did not want to call too frequently for an answer.

On September 16, 2002 I mailed a letter of inquiry via UPS regarding the status of our Year 4 486 approval letter. (Copy enclosed.)

A Form 486 Notification Letter dated October 16, 2002 was received with a change in the Service Start Date from July 1, 2001 to May 19, 2002 which results in a change in the Funding Commitment Knox County will be receiving.

A Letter of Appeal dated December 10, 2002 was sent via UPS to the SLD attaching all the same information I am sending you with the exception of the phone calls to Josh and Matt dated April 4 and July 9 which I referenced above.

On February 24, 2003, I received a call from Christine from SLD saying they were "working on my appeal".

I received an Appeal Denied letter dated April 14, 2003. (Copy enclosed)

I am also including copies of paperwork, etc. that my supervisor keeps in his files showing his knowledge that I mailed the original Form 486 on March 13, 2002.

Knox County Schools feel that we filed all paperwork adhering to the SLD guidelines both on date deadline and mailing via US Postal Service. As of today, May 30, 2003, the piece of mail postmarked March 14, 2002 has not been returned to us. Therefore, we feel it was received by the SLD within the proper time allotted. Knox County Schools has participated in the E-Rate program since it began in 1998 and we have always met all deadlines.

Thank you for your 2001-2002 E-rate application and for any assistance you provided throughout our review. We have completed review of your Form 471. This letter is to advise you of our decision(s).

FUNDING COMMITMENT REPORT

On the pages following this letter, we have provided a Funding Commitment Report for the Form 471 application cited above. We have reviewed each Discount Funding Request on your Form 471 application and have assigned a Funding Request Number (FRN) to each Block 5. The enclosed report includes a list of the FRNs from your application. The SLD is also sending this information to your service provider(s) so preparations can be made to begin implementing your E-rate discount(s) upon the filing of your Form 486. Immediately preceding the Funding Commitment Report, you will find a guide that defines each line of the Report.

NEXT STEPS

Once you have reviewed this letter and have determined that some or all of your requests have been funded, your next step to facilitate receipt of discounts as featured in this letter will be to file an FCC Form 486 with the SLD. The Form 486 notifies the SLD to begin payment to your service provider and provides certified indication that your technology plan(s) has been approved. The Form 486 and instructions can be found on the SLD web site at <www.sl.universalservice.org> or you can call the SLD Client Service Bureau at 1-888-203-8100 and ask that the form be sent to you. The new Form 486, dated July 2001 in the lower right corner, MUST be used for Funding Year 4 and for any previous funding years. Subsequent submissions of earlier versions of the Form 486 will be returned to you and will not be able to be processed. As you complete Form 486, you should also contact your service provider to verify they have received notice from the SLD of your funding commitments. After the SLD processes your Form 486, we can begin processing invoices from your service provider(s) so they can be reimbursed for discounted services they have provided you.

On December 21, 2000, the Children's Internet Protection Act was signed into law. That law will require schools and libraries that receive Universal Service discounts for certain services to adopt an Internet safety policy incorporating the use of filtering or blocking technology on computers with Internet access as a condition of receiving those discounts. THE LAW DOES NOT, HOWEVER, REQUIRE THIS TO BE IN PLACE FOR FUNDING YEAR 4. RECIPIENTS WILL HAVE TO CERTIFY, HOWEVER, THAT THEY ARE UNDERTAKING SUCH ACTIONS, INCLUDING NECESSARY PROCUREMENT PROCEDURES, TO PUT SUCH TECHNOLOGY PROTECTION MEASURES IN PLACE. For Funding Year 4 (the Funding Year beginning July 1, 2001), Billed Entities filing Form(s) 486 may encounter one or more situations that will affect their filing deadline(s). See the requirements for Funding Year 4 below and the Form 486

Instructions for more information on filing deadlines to ensure that your discounts can be paid retroactively to the Service Start Date. You are advised to keep proof of the date of mailing.

1. If Funding Year 4 services start on or before Sunday, October 28, 2001, and the date of your Funding Commitment Decision Letter is before Sunday, October 28, 2001, your Form 486 must be postmarked on or before October 28, 2001 in order for discounts to be paid retroactively to the Service Start Date. Failure to meet this certification deadline will result in reduced funding.
2. If your services start after October 28, 2001, your Form 486 must be postmarked no later than 120 days after the Service Start Date or 120 days after the date of the Funding Commitment Decision Letter, whichever is later, in order for discounts to be paid retroactively to the Service Start Date. Failure to meet this filing deadline will result in reduced funding.

You may also check the SLD web site at <www.sl.universalservice.org> or call the Client Service Bureau at 1-888-203-8100 for more information about how this new law might impact universal service discounts and any needed documentation for Funding Year 4 (July 1, 2001-June 30, 2002).

TO APPEAL THESE FUNDING COMMITMENT DECISIONS

If you wish to appeal the Funding Commitment Decision(s) (FCD) indicated in this letter, your appeal must be made in writing and RECEIVED BY THE SCHOOLS AND LIBRARIES DIVISION (SLD) at the SLD address below WITHIN 30 DAYS OF THE ABOVE DATE ON THIS LETTER. Failure to meet this requirement will result in automatic dismissal of your appeal. In your letter of appeal:

1. Include the name, address, telephone number, fax number, and e-mail address (if available) for the person who can most readily discuss this appeal with us.
2. State outright that your letter is an appeal. Identify which FCD Letter you are appealing. Indicate the relevant funding year and the date of the Funding Commitment Decision Letter. Your letter of appeal must also include the applicant name, the Form 471 Application Number, and the Billed Entity Number from the top of your FCD Letter.
3. Identify the particular Funding Request Number (ERN) that is the subject of your appeal. When explaining your appeal, include the precise language or text from the Funding Commitment Decision Letter that is at the heart of your appeal. By pointing us to the exact words that give rise to your appeal, the SLD will be able to more readily understand and respond appropriately to your appeal. Please keep your letter to the point, and provide documentation to support your appeal. Be sure to keep copies of your correspondence and documentation.
4. Provide an original authorized signature on your letter of appeal.

Please send your appeal to: Letter of Appeal, Schools and Libraries Division, Box 125 - Correspondence Unit, 80 South Jefferson Road, Whippany, NJ 07981. Appeals submitted by fax, phone call, and e-mail CANNOT be processed.

While we encourage you to resolve your appeal with the SLD first, you have the option of filing an appeal directly with the Federal Communications Commission (FCC): FCC, Office of the Secretary, 445-12th Street SW, Room TW-A325, Washington, DC 20554. If you are submitting your appeal to the FCC by other than United States Postal Services, the zip code you should use for this same address is 20024. If you are hand-delivering the appeal, check the SLD web site for more information. You should refer to CC Docket Nos. 96-45 and 97-21 on the first page of your appeal to the FCC. Your appeal must be made in writing and RECEIVED BY THE FCC at the FCC address above WITHIN 30 DAYS OF THE ABOVE DATE ON THIS LETTER. Failure to meet this requirement will result in automatic dismissal of your appeal. Further information regarding filing an appeal directly with the FCC can be found in the "Appeals Procedure" posted in the Reference area of the SLD web site <www.sl.universalservice.org>.

NOTICE ON RULES AND FUNDS AVAILABILITY

Applicants' receipt of funding commitments is contingent on their compliance with all statutory, regulatory, and procedural requirements of the universal service mechanisms for schools and libraries. FCC Form 471 Applicants who have received funding commitments continue to be subject to audits and other reviews that SLD or the Federal Communications Commission may undertake periodically to assure that funds have been committed and are being used in accordance with all such requirements. If the SLD subsequently determines that its commitment was erroneously issued due to action or inaction, including but not

limited to that by SLD, the Applicant, or Service Provider, and that the action or inaction was not in accordance with such requirements, SLD may be required to cancel these funding commitments and seek repayment of any funds disbursed not in accordance with such requirements. The SLD, and other appropriate authorities (including but not limited to USAC and the FCC), may pursue enforcement actions and other means of recourse to collect erroneously disbursed funds. The timing of payment of invoices may also be affected by the availability of funds based on the amount of funds collected from contributing telecommunications companies.

We look forward to continuing our work with you on connecting our schools and libraries through advanced telecommunications services.

A GUIDE TO THE FUNDING COMMITMENT REPORT

Attached to this letter will be a report for each E-rate funding request from your application. We are providing the following definitions.

FUNDING REQUEST NUMBER (ERN): A Funding Request Number is assigned by the SLD to each Block 5 of your Form 471 once an application has been processed. This number is used to report to Applicants and Service Providers the status of individual discount funding requests submitted on a Form 471.

FUNDING STATUS: Each ERN will have one of three definitions: "Funded," "Not Funded," or "As Yet Unfunded."

1. An ERN that is "Funded" will be approved at the level that SLD determined is appropriate for that item. The funding level will generally be the level requested unless the SLD determines during the application review process that some adjustment is appropriate.
2. An ERN that is "Not Funded" is one for which no funds will be committed. The reason for the decision will be briefly explained in the "Funding Commitment Decision," and amplification of that explanation may be offered in the section, "Funding Commitment Decision Explanation." An ERN may be "Not Funded" because the request does not comply with program rules, or because the total amount of funds in the Universal Service Fund was insufficient to fund all requests.
3. An ERN that is "As Yet Unfunded" reflects a temporary status that is assigned to an ERN when the SLD is uncertain at the time the letter is generated whether there will be sufficient funds to make commitments for requests for internal connections at a particular discount level. For example, if your application included requests for discounts on both telecommunications services and internal connections, you might receive a letter with our funding commitment for your telecommunications funding requests and a message that your internal connections requests are "As Yet Unfunded." You would receive a subsequent letter(s) regarding the funding decision on your internal connections requests.

SERVICES ORDERED: The type of service ordered from the service provider, as shown on Form 471.

SPIN (Service Provider Identification Number): A unique number assigned by the Universal Service Administrative Company to service providers seeking payment from the Universal Service Fund for participating in the universal service support programs. A SPIN is also used to verify delivery of services and to arrange for payment.

SERVICE PROVIDER NAME: The legal name of the service provider.

CONTRACT NUMBER: The number of the contract between the eligible party and the service provider. This will be present only if a contract number was provided on Form 471.

BILLING ACCOUNT NUMBER: The account number that your service provider has established with you for billing purposes. This will be present only if a Billing Account Number was provided on Form 471.

EARLIEST POSSIBLE EFFECTIVE DATE OF DISCOUNT: The first possible date of service for which the SLD will reimburse service providers for the discounts for the service.

CONTRACT EXPIRATION DATE: The date the contract expires. This will be present only if a contract expiration date was provided on Form 471.

SITE IDENTIFIER: The Entity Number listed in Form 471, Block 5, Item 22a will be listed. This will appear only for "site specific" ERNs.

PRE-DISCOUNT AMOUNT: Amount in Form 471, Block 5, Item 23, Column I, as determined through the application review process.

DISCOUNT PERCENTAGE APPROVED BY THE SLD: This is the discount rate that the SLD has approved for this service.

FUNDING COMMITMENT DECISION: This represents the total amount of funding that the SLD has reserved to reimburse service providers for the approved discounts for this service through June 30, 2002. It is important that you and the service provider both recognize that the SLD should be invoiced and the SLD may direct disbursement of discounts only for eligible, approved services actually rendered.

FUNDING COMMITMENT DECISION EXPLANATION: This entry may amplify the comments in the "Funding Commitment Decision" area.



Per our discussion this afternoon, I was suprised to learn of any issue regarding Funding Reimbursements for Telecommunications in the 2001 Funding Cycle. In an effort to reclafie this unfortunate situation I have reviewed the office documentation that we kept in this regard.

As we discussed, it is very difficult to assert documents the path taken by this documentation after it was sent US Mail. While we cannot assert that parcels sent via US mail are actually received by the party to which they are addressed, this parcel has not been returned to our office as non-deliverable. Nevertheless, the advice the SLD in this filing year had recommended that for documents that were not pushing deadlines that the use of the U S Postal Service was viable. However, it seems that there was no oversight mechanism provided so that district could assert that the documentation had been received.

I hope that the SLD understood that we attempted to on several occasions prior to and after the deadline of April 14, 2002 to assert that the documents had been received. On each attempt, we were assured by the representatves of the SLD that documentation forwarded in March would most certainly have arrived prior to the deadline and that, while "they" could not actually "put their hands on the form" is was surely "in process." As I remember we were further aprised that the SLD was in a leadership transition and the Year 4 (2001) processing would be delayed in an effort to escalate the processing of Year 5 (2002) applications and that we should remain patient with the process during the transition. Finally, as we explored this issue further, we were assured that "any details" regarding the reimbursements involving this 486 could be resolved easily through a little "simple documentation".

I feel that aside from being able to assert that the documents were produced and reviewed in a timely manner, I am a little bit of a loss as to what the SLD might want us to provide to document our effort.

Nevertheless, here is the documentation that I was able to assemble regarding the March 2002 Form 486 submission.

- Attached is a dated copy of the original memo that I had sent confirming that I had reviewed this submission and agreed that it was ready to be sent. You will note that I completed the memo on Tuesday, March 12th. The memo was delivered to you the morning of March 13th, 2002.
- I have also attached a recent screen capture showing a file creation date of the afternoon of March 12, 2002.
- I also noted that in our final file copy you had a hand written notation that the documents had been mailed March 14, 2002. This is consistent with these other documents.

While I do not know if this will be helpful, it will at least confirm to you that I recall and had reviewed the Form 486 in question in a timely manner and that there is no reason to expect that this document would be received at the SLD beyond the April14th deadline required for this document to be received. Surely, even the US Mail would have delivered this document within a month's time.

I will note that there seems to have been an extraordinarily high incidence in problems within the SLD regarding our 2001 application. As I understand it, there are still Funding Requests for our district that have not reviewed.

It is unfortunate that the SLD has chosen to penalize the children of Knox County for the inadequacies of the United States Postal Service or of the doucment handling at the SLD in a time of transition.

Hopefully we can use these documents to craft an appeal to the FCC. Please iet me know if there is anything else that I might do to be of assistance in this matter.
