**NOTICE OF DEPOSITION UPON ORAL EXAMINATION**



The Enforcement Bureau (the "Bureau"), pursuant to Section 1.315(a) of the Commission's rules, 47 C.F.R. § 1.315(a), hereby gives notice that it intends to take the deposition upon oral examination of Shannon Dennie of Business Options, Inc. 


