ERRATUM

KAGM, LLC,¹ licensee of Station KAGM, Strasburg, Colorado and On-Air Family, LLC, licensee of KBRU-FM, Fort Morgan, Colorado, by their counsel, submit this brief Erratum to their Petition for Rule Making, filed on April 24, 2003, to identify two errors that appear in the Commission's engineering data base for the proposal.

1. The data base incorrectly reports the coordinates for the allotment of Channel 275C1 at Laramie, Wyoming. The correct coordinates are 40-53-55 North Latitude, 105-42-31 West Longitude. The Technical Narrative, Figure 16, gave the correct coordinates. The text (page 13, paragraph 11) gave the incorrect coordinates and should be corrected as set forth herein. The data base entry should also be corrected.


2. The Commission's data base incorrectly reports the West Longitude ("WL") coordinates for the allotment of Channel 273C2 at Loveland, Colorado as 104-52-52 WL. The correct coordinates are 104-52-22 WL Both the text (page 12, paragraph 9) and the Technical Narrative, Figure 12, gave the correct coordinates. The data base entry should be corrected.


