**ORDER**

**Adopted: June 13, 2003**

By the Telecommunications Access Policy Division, Wireline Competition Bureau:

1. Ahead Communications Systems (Ahead Communications), Middlebury, Connecticut, seeks review of a decision by the Schools and Libraries Division (SLD) of the Universal Service Administrative Company (Administrator).<sup>1</sup> Prior to the time that Ahead Communications filed its request with the Commission, it also filed an appeal of the same decision with SLD.<sup>2</sup> The Commission's rules do not contemplate simultaneous appeals of SLD's decisions to the Administrator and the Commission.<sup>3</sup> We therefore dismiss without prejudice Ahead Communications' Request for Review to the Commission. Once the Administrator has issued its decision, Ahead Communications may then appeal to the Commission, if it believes such an appeal is warranted at that time.<sup>4</sup>
