**REPORT AND ORDER**  
**(Proceedings Terminated)**

**Adopted: May 7, 2003**

**Released: May 9, 2003**

By the Assistant Chief, Audio Division:

1. The Audio Division has before it *Notices of Proposed Rule Making*, specified below, setting forth four separate proposals to allot an FM channel to a specific community. Each petitioner filed comments in support of its proposal reaffirming its intention to apply for the specified channel, if allotted. Each proposal complies with all Commission technical requirements and we continue to believe that each proposal would serve the public interest. Accordingly, we adopt each proposal as originally proposed. These are as follows:

**A. MB Docket No. 03-42; RM-10648**

**Action:** At the request of Gray Media Corporation, we are allotting Channel 293C3 at Daisy, Arkansas, as the community's first local aural transmission service.<sup>1</sup>

**Coordinates:** The reference coordinates for Channel 293C3 at Daisy are 34-21-49 NL and 93-54-48 West Longitude.

**Additional Information:** This allotment requires a site restriction of 21.1 km (13.1 miles) northwest of Daisy at the coordinates indicated above.

**B. MB Docket No. 03-30; RM-10644**

**Action:** At the request of Dana J. Puopolo, we are allotting Channel 255A at Trona, California, as the community's first local aural transmission service.<sup>2</sup>

**Coordinates:** The reference coordinates for Channel 255A at Trona are 35-43-51 NL and 117-18-28 West Longitude.

**Additional Information:** This allotment requires a site restriction of 6.8 km (4.2 miles) southeast of Trona at the coordinates indicated above.

**C. MB Docket No. 03-29; RM-10643**

**Action:** At the request of David P. Garland, we are allotting Channel 286A at Muldrow, Oklahoma, as the community's first local aural transmission service.<sup>3</sup>

**Coordinates:** The reference coordinates for Channel 286A at Muldrow are 35-29-47 NL and 94-36-04 West Longitude.

**Additional Information:** This allotment requires a site restriction of 10.02 km (6.52 miles) north of Muldrow at the reference coordinates indicated above.

**D. MB Docket No. 03-43; RM-10649**

**Action:** At the request of Gray Media Corporation, we are allotting Channel 258A at Rattan, Oklahoma, as the community's first local aural transmission service.<sup>4</sup>

**Coordinates:** The reference coordinates for Channel 258C at Rattan are 34-07-58 NL and 95-23-57 West Longitude.

Accordingly, pursuant to the authority contained in Sections 4(i), 5(c)(1), 303(g) and (r) and 307(b) of the Communications Act of 1934, as amended, and Sections 0.61, 0.204(b) and 0.283 of the Commission's Rules, IT IS ORDERED, That effective June 23, 2003, the FM Table of Allotments, Section 73.202(b) of the Commission's Rules, IS AMENDED for the communities listed below, as follows:
