NOTICE OF DEPOSITION UPON ORAL EXAMINATION**

1. The Enforcement Bureau (the "Bureau"), pursuant to Section 1.315(a) of the Commission's rules, 47 C.F.R. § 1.315(a), hereby gives notice that it intends to take the deposition upon oral examination of Samuel Delug of NOS Communications, Inc. ("NOS"), Affinity Network, Incorporated ("ANI"), and NOSVA Limited Partnership ("NOSVA") (collectively "NOS/ANI"), 4380 Boulder Highway, Las Vegas, Nevada 89121. In their July 1, 2003 responses to the Bureau's First Interrogatories and their July 11, 2003 responses to the Bureau's Requests for Admission of Fact and Genuineness of Documents, NOS/ANI represented that Mr. Delug is a 50% shareholder of NOS, a 49.4% shareholder of ANI, a limited partner and 49.5% owner of NOSVA, and a 50% shareholder of NOS Communications of Virginia, Inc., NOSVA's General Partner.

2. Mr. Delug will be examined before a notary public or other person authorized to administer oaths on August 26, 2003, in Los Angeles, California, at a time and place agreed to by


