Based on our discussions and in order to provide the Commission with materials responsive to the Initial Information and Document Request dated July 8, 2003 ("Request") in a manner that is both expeditious and efficient, The News Corporation Limited ("News Corp.") has identified certain individuals who are likely to have responsive materials. These individuals are listed by document request number on Attachment A. The individuals on Attachment A have been selected from a list of key persons at News Corp. whose documents have been collected in the course of responding to the Department of Justice's inquiries. These individuals are listed on Attachment B. News Corp. has also identified certain members of the team of economists at Charles River Associates, Inc. who prepared a submission in this proceeding.
