
**SUPPLEMENT TO
PETITION FOR STAY**

The American Society of Association Executives (“ASAE”)¹ filed a Petition for Stay with the Commission on July 25, 2003 seeking a stay of the rules governing unsolicited facsimile advertisements as they apply to tax exempt nonprofit organizations. ASAE seeks now to supplement its Petition for Stay by adding as supporters of that Petition the following tax exempt nonprofit organizations and other interested parties, listed in Exhibit A. ASAE filed simultaneously with the Commission a Petition for Emergency Clarification of the unsolicited facsimile advertisement rules as they apply to tax exempt nonprofit organizations. On behalf of these close to seven hundred tax exempt nonprofit organizations and others, ASAE respectfully reiterates its petition that the Commission, if it is unable to clarify the unsolicited facsimile advertisement rules on an emergency basis prior to their August 25, 2003 effective date, stay the rules as they apply to tax exempt nonprofit organizations until the Commission completes its consideration of this issue.


