**Re: Consolidated Application of General Motors Corporation, Hughes Electronics Corporation, and the News Corporation Limited for Authority to Transfer Control (MB Docket No. 03-124)**

Dear Ms. Dortch:

Attached to this letter, please find the response of Cablevision Systems Corporation ("Cablevision") to the Commission's July 15, 2003 Discovery Requests for Cablevision ("Request" or "Requests"). This letter details the procedures that Cablevision followed in preparing its response.

1. **Request 1.a.3 ("all periods of time in which the MVPD's right to carry the network lapsed"):** Cablevision is providing data regarding those periods of time where carriage of a relevant video programming network ceased, and has not included the dates of periods of time where the MVPD's right may have briefly "lapsed" due to an affiliation agreement expiring before the parties reached a new agreement but carriage of the network did not cease. Instances where carriage was terminated due to nonpayment by the MVPD during the term of an affiliation agreement have also not been included.
2. **Request 1.a.4:** Cablevision is providing, for each relevant video programming network, for each year beginning in 2003, the total aggregate number of subscribers covered by expiring affiliation agreements (estimated based on number of current subscribers).

3. **Request 1.a.6:** Cablevision is not responding to this request at this time.
4. **Request 2(c):** Cablevision is providing data for the same time period indicated in Request 1, *i.e.*, January 1, 2000 through the present.
5. **Request (2)(d)(3), (4):** Cablevision is providing data with respect to each relevant video programming service (not with respect to "News Corp.," as stated in the Request).
6. **Request 3:** Cablevision is providing data for the relevant video programming networks.
7. **Available Data:** Cablevision responses have been provided using the data and level of detail that Cablevision maintains in the ordinary course of its business.
8. **Applicants' procedures for responding to July 8, 2003 Initial Information and Document Request.** To the extent possible, Cablevision has attempted to tailor its responses to the procedures set forth by the Applicants in responding to the Commission's July 8, 2003 Initial Information and Document Request. To the extent the Applicants struck, limited or narrowed their responses through their procedures, Cablevision has done the same.

As the Commission understood when it issued the *Second Protective Order*<sup>1/</sup> in this proceeding, much of the information it has requested from Cablevision is highly confidential. Under the terms of the *Second Protective Order*, Cablevision is a Submitting Party and the information it is submitting herewith is therefore entitled to the enhanced confidential treatment prescribed in the *Second Protective Order*. Cablevision herewith submits a redacted version of the enclosed documents for the public record in accordance with the *Second Protective Order*.

**b. the cost to develop or launch the network, including a description and quantification of each major category of costs**

The costs of developing the relevant video programming networks are not readily known, because Cablevision keeps no documents in the ordinary course of its business summarizing such historical costs. Given the substantial time that has elapsed since their launch and the fact that some started as different networks before evolving into their current form, ascertaining the cost to develop and launch the networks would require extensive historical research and could only be accomplished at significant expense and effort.

Generally, the greatest cost by far to develop or launch a sports-related video programming network is the cost of obtaining the programming, *e.g.*, licensing the rights from the sports teams. Other costs would include marketing, personnel, cost of the physical plant, and infrastructure for distribution of the network to affiliates.
