
Pursuant to Section 1.1206 of the Federal Communications Commission's ("FCC's" or "Commission's") Rules, 47 C.F.R. § 1.1206, this letter provides notice that on September 10, 2003, Thomas J. Buchanan, General Counsel of Corr Wireless Communications, LLC ("Corr Wireless" or "Company"), and Catherine Wang and Wendy M. Creeden of Swidler Berlin Shereff Friedman, LLP, met with Paul Garnett and Cara Voth of the Telecommunications Access Policy Division of the Wireline Competition Bureau of the FCC to discuss the Company's above-reference Rural ETC Petition currently pending before the Commission.



