**SUPPLEMENTAL PETITION FOR RULEMAKING**

Vision Media Incorporated ("Vision"), licensee of station KVMI, FIN 41898, Arthur, North Dakota, hereby supplements its prior petition for rulemaking (the "original petition"), filed December 7, 2001, to amend Section 73.202(b) of the Commission's rules, the FM Table of Allotments for Channel 280C at Hazelton, North Dakota and to modify the license of station KVMI to specify operations on Channel 280C1 at Arthur, North Dakota.

Vision incorporates, by reference, all arguments made in its original petition and restates its interest in operating KVMI on Channel 280C1 at Arthur, North Dakota.

Vision amends the original petition to reflect the KVMI's current operating status; since the original petition was filed, the Commission has licensed KVMI to operate on Channel 280C3. While KVMI still seeks authorization to operate on Channel 280C1 at Arthur, North Dakota, the rulemaking must, by necessity, be modified to reflect that such an authorization now requires the relocation of KVMI from its current Channel, 280C3, to the requested channel,


