Specifically, AT&T seeks withdrawal of the issues relating to unproductive truck rolls, which were raised at pages 58-61 of its Comments and pages 34-36 of its Reply Comments, and in the accompanying declarations. In addition, in light of the current status of these issues in this proceeding, AT&T also seeks withdrawal of the issues relating to non-recurring charges for line splitting, which were raised at pages 43-49 of its Comments and pages 41-44 of its Reply Comments, and in the accompanying declarations. AT&T reserves the right to continue to pursue each of these issues with SBC and, if necessary, in court, before the relevant state commission, or before this Commission.
