Present on-line: Becky Jo Clark, Joel Bunis, Bob Bernstein, Terry Jones and John Dolphin, Consultant.

1. Discussed time of next partnership meeting. Set for 10:00 a.m. for Executive Committee for December 1, 1990 with General Partnership meeting to begin at 1:00 p.m. Place: Bob Bernstein's law offices. Another General Partnership meeting will probably be held in January.
2. Sale of Joel Bunis' 2% interest: both Ed Rogers and Cellular Dreams have expressed interest to purchase it, but Cellular Dreams has been unable to get in touch with Mr. Rogers regarding the purchase and the time period is almost up. Consensus of opinion is for Becky Jo Clark to write a letter dated this Friday if Cellular Dreams still has not contacted Mr. Rogers. Clark's letter will give Mr. Rogers seven days from the date of the letter to get with Kandace Dolphin to coordinate the sale. If Mr. Rogers has not complied in that period of time, Cellular Dreams will be entitled to the full 2% share and will purchase it from Joel Bunis.
3. Unanimous approval was given by the Executive Committee for Becky Jo to sign the Letter of Agreement, Switch Sharing Agreement and Management Agreement with Metro Mobile. All members of the partnership present at the last general Partnership meeting voted their approval to allow the Executive Committee to enter into the contract. Written proxies from Vincent De Costanzo, Nancy Kelner and Amir Riahi plus one unidentified partner gave the additional votes for the quorum required for approval. The three documents can be signed contingent upon minor revisions discussed.
4. A general consensus was given for Motorola to give us a New Financial Commitment Letter required by the FCC for a cost of \$1000. This is to replace the Columbia Security letter. It should be signed shortly.
5. No further communication has been received from CGI since Clark signed the letter drafted by John Dolphin stating that we were not going to pay them any more money due to their nonadherence to our contract.

3. Discussion regarding proposal from Committee for Executive Committee reimbursement. Counter proposal is:
  - A. Beginning January 1, 1991 \$600 a month to the president, paid in advance plus expenses paid, including secretarial.
  - B. \$400 a month to the Treasurer.
  - C. \$400 a month to Committee person with legal expertise.
  - D. \$200 a month to other Committee person.
4. Compensation for past performance for the Executive Committee will be \$38,400 - a prorated share to be paid at sale of a partners interest based upon the percentage of ownership at inception of partnership.
5. As cash flow becomes available, one option is that the Executive Committee can be paid from the cash flow - 80% to partnership and 20% to the Executive Committee. As it will be some time before this is available. for the year 1990. any interests to be sold will pay their prorated shares of the Executive Committee's fees on a monthly basis at the time of the sale. After 1990. the capitalization of these fees should be explored.


