Dear Mr. Muleta:

On September 20, 2000, the Association of Public-Safety Communications Officials-International, Inc. ("APCO") filed a petition for reconsideration of a Commission decision granting VoiceStream (now "T-Mobile") a waiver of the wireless E9-1-1 rules. APCO argued therein that VoiceStream had not provided adequate information to demonstrate that its proposed location technology solution would provide sufficient accuracy to meet public safety requirements. Since that time, VoiceStream has been subject to Commission enforcement actions and has entered into a consent decree with the Commission regarding its E9-1-1 implementation. VoiceStream has also changed its location technology selection.

Therefore, we believe that the original APCO petition for reconsideration is now moot and we hereby request its withdrawal from consideration.
