



**471 Application**

a) Based on the attached 471 Applications (Exhibits A and B), the SLD committed reversal error when it modified the “shared discount” percents

The District calculated its discount in accordance with the FCC's 471 Instructions, and, more specifically, the SLD's "Alternative Discount Mechanisms Fact Sheet", Number 7 (Projections Based on Surveys). See,

**7. Projections based on surveys**

**If a school has sent a questionnaire to all of its families, and if it receives a return rate of at least 50 percent of those questionnaires, it may use that data to project the percentage of eligibility for E-rate purposes for all students in the school. For example, a school with 100 students sent a questionnaire to the 100 homes of those students, and 75 of those families returned the questionnaire. The school finds that the incomes of 25 of those 75 families are at or below the IEG for NSLP. Consequently, 33 percent of the students from those families are eligible for E-rate purposes. The school may then project from that sample to conclude that 33 percent of the total enrollment, or 33 of the 100 students in the school, are eligible for E-rate purposes. *Id.***

- b) Complete documentation was provided to the SLD (Exhibit C). The SLD requested supporting documentation and Applicant's Exhibit C substantiates the District's discount
- c) **The shared discount percentages should not have been modified by the SLD.**
