



In this submission, we are appealing the Schools and Libraries Division of USAC's ("SLD") decision on appeal for the funding year 2003, also attached herein as Attachment A. In brief, the SLD has determined that Cook County School District #130 ("applicant") could not prove that the original Form 470 was certified within the Feb. 6, 2003 close of the window for Funding Year 2003.

We agree with the SLD that we cannot produce a post-office generated receipt or confirmation of having sent in the pages on 10/10/02. Instead, we have provided another copy of the original Block 6 certification page, of which we attach another copy here (as Attachment B). We certify here that this is a copy of the original that was sent on 10/10/02 date.

## Issues in the Case:


Anthony Cucci delivered the unsigned Form 470 for funding year 2003-2004 to the School District 130 Superintendent's (Dr. Barbara Mackey) office for signature on 9/27/2002 after attending the Illinois Board of Education Workshop. At this workshop Anthony Cucci submitted the Form 470 online with paper certification. The Dr. Barbara Mackey signed the Form 470 on 10/10/02 and gave the form to Anthony Cucci who made copies then mailed the Form 470 signature page to the Schools and Libraries Division (SLD). There is a possibility that this Form 470 was lost in the mail or lost at the SLD. This same scenario (lost Form 470) happened the previous funding year 2002-2003, but in this case Anthony Cucci was able to produce a receipt proving that the district mailed it on time etc. The SLD for that year never acknowledged that they lost the Form 470 and then finally approved the application a year later for the 2002-2003 funding.

After SLD informed our School District 130 that the Form 470 for 2003-2004 funding year was not filed on time, we appealed the SLD decision. Ricardo Tostado from the Illinois Board of Education, allowed our School District 130 to use the State Board of Education's Form 470 number (383730000413920) as it did include telecommunications services. Our School District 130 used this number to get our Telecommunications funding approved for the district. The person from the SLD was Eric J. Flock who accepted this Form 470 number while our appeal for the lost Form 470 number was being processed (Attachment C - email document dated June 9, 2003). Throughout the month of June 2003, Eric J. Flock (SLD) and Anthony Cucci (SD130) exchanged information back and forth over the telephone and fax machines to get approval for the Internal Connections for 2003-2004 funding year. Example: Anthony Cucci sent Eric (SLD) copies of the Internal Connections vendor's plans for products and labor etc. with the understanding that everything was now OK for our Form 470. Then on July 1, 2003 Eric J. Flock (SLD) called Anthony Cucci and asked Anthony again for the establishing Form 470 number. Anthony asked Eric why? Eric said that SLD needed another email from School District 130 authorizing SLD to process the Form 470. Anthony asked Eric about the number that Eric had received back on June, 2003. Eric then suggested that Anthony use the original Form 470 number that was being appealed because he saw no problem using that number. As you can see from the email dated July 1, 2003 (Attachment D), Anthony Cucci gave Eric J. Flock (SLD) the original Form 470 number and Anthony also noted in the email that he does not have proof of mail notification. Eric said it was fine! Soon (within a week) after Anthony emailed Eric J. Flock (SLD), the Schools and Libraries Division rejected School District 130's Internal Connections for funding year 2003-2004. We feel this was inappropriate and unfair.

The online systems showed that our Form 470 was filed, and we continued to put together a list of proposals and vendors for the Form 471. The online system allowed entries to be made with the assumption that a Form 470 is on file and certified. The SLD online system accepted our Form 471 within the February 6, 2003 close window. This let us believe that everything was ok for the Form 470 as well, because you should not be able to submit for approval a Form 471 without having valid Form 470 filed.

Please reconsider our clam and allow us to continue to provide the necessary infrastructure for our teachers and students. Don't hesitate to call with any further questions or concerns.

After thorough review and investigation of all relevant facts, the Schools and Libraries Division ("SLD") of the Universal Service Administrative Company ("USAC") has made its decision in regard to your appeal of SLD's Year 2003 Funding Commitment Decision for the Application Number indicated above. This letter explains the basis of SLD's decision. The date of this letter begins the 60-day time period for appealing this decision to the Federal Communications Commission ("FCC"). If your letter of appeal included more than one Application Number, please note that for each application for which an appeal is submitted, a separate letter is sent.

Decision on Appeal: **Denied in full**  
Explanation:

- In addition to your letter of appeal, you have included a copy of your Form 470, Block 1 & 5 pages. You claim that the 470 Certification page, with the signature date of 10/10/02, was mailed on a timely basis. Additionally, you claim not to be responsible for the delivery of this certification, which you assert, appears to have been lost in the mail. Furthermore, you claim that the lack of the receipt of the certification has not affected your solicitation of bids for services and tentative contractual agreements
- PIA reviewed the filed Form 470 and contacted you to confirm if the Form 470 was indeed the establishing Form 470. You were advised that the receipt of the certification page within the window was critical for compliance with this support mechanism. In your response, you volunteered that you did not have a mail notification receipt for the Block 6 certification page. Since there is no proof of mailing within the window, we are dependent on the electronic date records. To be eligible as a valid posting of the Form 470, the certification page must be received within the filing window. Since the Form 470 certification page was not received within the window, and there is no proof of mailing, the FRN is denied in full.
- Program rules for Funding Year 2003 require that Form 470 Certifications be postmarked no later than February 6, 2003 in order for the Form 470 to be valid and establish the bidding for these services. Since our records indicate that your Form 470 Certification did not meet this requirement, it cannot be used to establish the bidding for this service. During initial review, you indicated that this was the establishing Form 470. Consequently, your appeal is denied for referencing a Form 470 that was not certified before the close of the filing window.

If you believe there is a basis for further examination of your application, you may file an appeal with the Federal Communications Commission (FCC). You should refer to CC Docket No. 02-6 on the first page of your appeal to the FCC. Your appeal must be received or postmarked within 60 days of the above date on this letter. Failure to meet this requirement will result in automatic dismissal of your appeal. If you are submitting your appeal via United States Postal Service, send to: FCC, Office of the Secretary, 445 12th Street SW, Washington, DC 20554.
