("Starboard") by Counsel, and pursuant to Sections 1.415 and 1.420 of the Commission's Rules and the instructions set forth in *In re Amendment of Section 73.202(b), Table of Allotments, FM Broadcast Stations (Various)*, DA-04-910 (Released April 5, 2004), hereby respectfully submits its Comments in support of the above-captioned Notice of Proposed Rule Making (NPRM) for reservation of FM Channel 258A at Cedarville, Illinois for noncommercial educational (NCE) use.

Starboard supports The Catholic Diocese of Rockford's Petition for reservation of Channel 258A at Cedarville, Illinois for NCE use. Starboard, as a non-profit organization, has a general interest in reservation of FM Channels for NCE use, and has filed several Petitions of its own for reservation of a number of vacant FM Channels for NCE use.
