("Starboard") by Counsel, and pursuant to Sections 1.415 and 1.420 of the Commission's Rules and the instructions set forth in *In re Amendment of Section 73.202(b), Table of Allotments, FM Broadcast Stations (Various)*, DA 04-910 (Released April 5, 2004), hereby respectfully submits its Comments in support of the above-captioned Notice of Proposed Rule Making (NPRM) for reservation of FM Channel 242A at Farmersburg, Indiana for noncommercial educational (NCE) use.

Starboard hereby reiterates its interest in reservation of Channel 242A at Farmersburg, Indiana and hereby incorporates by reference all the arguments made for such reservation in its original Petition for Reservation. Starboard also reiterates that it intends to file an application for this frequency if it is reserved for NCE use.
