Dear Ms. McGrath:

On behalf of Cingular Wireless Corporation (“Cingular”), transmitted herewith please find a series of sealed boxed documents responsive to the document production portions of the July 30, 2004 Information Request (“Information Request”).¹ Given the volume of responsive documents, the document production is being delivered to the Commission on a rolling basis. 
