COMMENTS OF MISSISSIPPI BROADCASTING PARTNERS

Mississippi Broadcasting Partners ("MBC"), licensee of WABG-TV, Greenwood, Mississippi, by its attorneys and pursuant to Sections 1.415 and 1.420 of the Commission's Rules (47 C.F.R. §§ 1.415, 1.420), hereby respectfully submits these comments in response to the above-captioned *Notice of Proposed Rule Making* ("Notice"), released by the Commission on May 21, 2004. The *Notice* seeks comment on MBC's request, as set forth in its *Petition for Rule Making* filed on February 23, 2004 and supplemented on April 30, 2004 and May 6, 2004 ("Petition"), that the Commission amend Section 73.622(b), the DTV Table of Allotments, by substituting Channel 32 as the station's paired DTV allocation in lieu of Channel 54, as originally allotted.

As described in the *Petition*, adoption of the proposal would serve the public interest by permitting WABG-DT to commence operations on a core channel and by facilitating the reallocation of non-core spectrum prior to the end of the DTV transition. MBC hereby confirms its continuing desire and intent to construct and operate Station WABG-DT on Channel 32.



Upon the Commission's adoption of changes in the DTV Table of Allotments as described in the *Notice*, MBC will timely file an application specifying the operation of WABG-DT on Channel 32 in accordance with applicable Commission rules and policies governing construction and commencement of DTV operation.

THEREFORE, for the reasons previously set forth in the *Petition*, MBC respectfully requests that the Commission promptly adopt the changes proposed in the *Notice* and amend Section 73.622(b) of its Rules to substitute Channel 32 for Channel 54 for use by WABG-DT in Greenwood, Mississippi.
