**Description of Transaction and Public Interest Statement**

Cingular Wireless Spectrum Sub B LLC (“Lessor”), a subsidiary of Cingular Wireless LLC (“Cingular”), and Omnipoint NY MTA License, LLC (“Lessee”), a subsidiary of T-Mobile USA, Inc. (“T-Mobile”) (collectively, the “Parties”), hereby seek Commission approval of a Long Term *De Facto* Lease Agreement (“Lease Agreement”) regarding the broadband PCS spectrum referenced herein.<sup>1</sup>

In each of the referenced markets, the Parties are currently operating pursuant to a network infrastructure-sharing arrangement under which the Parties jointly own and control the networks. In anticipation of the proposed merger between Cingular Wireless Corporation and AT&T Wireless Services, Inc. (“AWS”) (the “Cingular-AWS Merger”),<sup>2</sup> and on the condition that the merger is consummated, the Parties have decided to unwind this network sharing arrangement so that Cingular and T-Mobile ultimately will operate separate networks in the subject market areas. To accomplish this, the following steps are contemplated following consummation of the Cingular-AWS Merger:

- Cingular’s interest in the network infrastructure will be sold to a T-Mobile affiliate.
- During a transition period, Lessor intends to migrate its customers to the networks it proposes to acquire from AWS.
- Until the transition is completed, Lessee will lease spectrum from Lessor and make available to Lessor services on a wholesale basis.<sup>3</sup>

Pursuant to the terms of the Lease Agreement, Lessor, whose qualifications and eligibility as a licensee are matters of Commission record, will retain *de jure* control of the leased spectrum, but will transfer *de facto* control to the Lessee for the duration of the lease term.<sup>4</sup> Lessee, whose qualifications and eligibility also are matters of Commission record, will conduct operations under the Lease Agreement subject to applicable rules and regulations including, without limitation, the provision of E-911 services in accordance with law. The proposed lease raises no competitive or other public interest concerns and as set forth below, raises no unsettled foreign ownership issues.

Accordingly, the leasing arrangement disclosed herein is consistent with the public interest, convenience and necessity.<sup>5</sup>

**Response to Questions 136-137**

Under Section 310(b)(4) of the Act, the Commission must determine whether the public interest would be served by allowing a common carrier licensee to have indirect foreign ownership that exceeds 25 percent.<sup>6</sup> Through T-Mobile, foreign entities and persons indirectly hold 95.56 percent of the attributable ownership interest in Lessee.<sup>7</sup> On April 27, 2001, the Commission issued an order granting the applications of T-Mobile (then named VoiceStream Wireless Corporation ("VoiceStream")) for authority to transfer control of its licensee subsidiaries to a wholly owned U.S. subsidiary of Deutsche Telekom AG (a German entity) ("DT") to effect a merger between VoiceStream and DT.<sup>8</sup> The Commission found that DT's indirect investment in VoiceStream and its licensee subsidiaries, including Lessee, in excess of the 25 percent benchmark set forth in Section 310(b)(4), is consistent with the public interest.<sup>9</sup> Specifically, the Commission authorized up to 100 percent indirect foreign investment in T-Mobile and its licensee subsidiaries, including Lessee, by DT and its German shareholders, and by the German government through its investment in DT (up to and including 43 percent).<sup>10</sup> The

Commission subsequently approved 100 percent indirect foreign investment in several other T-Mobile licensee subsidiaries.<sup>11</sup> Because the Commission previously approved the ownership structure of Lessee, the acquisition of a lessee interest in additional licenses by this entity requires no new foreign ownership analysis and is otherwise in the public interest.

**Request for Conditional Grant in Compliance with FBI/DOJ Agreement**

T-Mobile requests that the FCC condition the grant of the approval of the proposed Lease Agreement on compliance with the provisions of the January 12, 2001, Agreement with the Department of Justice (“DOJ”) and the Federal Bureau of Investigation (“FBI”) (“DOJ/FBI Agreement”)<sup>12</sup> upon which the approval of the merger between T-Mobile and DT was based.<sup>13</sup> The requirements of the DOJ/FBI Agreement are binding on DT and DT’s subsidiaries, including T-Mobile. Section 7.2 of the DOJ/FBI Agreement provides:

DT agrees that in its applications or petitions to the FCC for licensing or other authority filed with the FCC after the Effective Date, except with respect to pro forma assignments or pro forma transfers of control, it shall request that the FCC condition the grant of such licensing or other authority on DT’s compliance with the terms of this Agreement . . . .<sup>14</sup>

The DOJ/FBI Agreement prescribes specific language for the conditional grant of interests in FCC licenses at Exhibit A to the DOJ/FBI Agreement:

It is further ordered, that the authorizations and the licenses related thereto are subject to compliance with the provisions of the Agreement attached hereto between Deutsche Telekom AG, VoiceStream Wireless Corporation, VoiceStream Wireless Holding Corporation on the one hand, and the Department of Justice (the “DOJ”) and the Federal Bureau of Investigation (the “FBI”) on the other, dated January 12, 2001, which Agreement is designed to address national security, law enforcement, and

public safety issues of the FBI and the DOJ regarding the authority granted herein. Nothing in the Agreement is intended to limit any obligation imposed by Federal law or regulation including, but not limited to, 47 U.S.C. § 222(a) and (c)(1) and the FCC's implementing regulations.<sup>15</sup>

**Response to Schedule B, Questions 3(a) and 3(b)**

The Lease Agreement was executed on May 24, 2004. By its terms, Lessee's rights to use the leased spectrum under the Lease Agreement will commence following Commission approval of the instant application and the satisfaction of certain other contractual conditions (including consummation of the Cingular-AWS Merger), and will continue in effect until expiration of the underlying license term. The Parties contemplate that the leasing arrangement will be renewed, subject to applicable license renewal and other regulatory requirements, for a total period of up to four (4) years from the commencement date. During the term of the Lease Agreement, it is anticipated that certain of the spectrum usage rights detailed herein will terminate upon the consummation of related transactions, or will incrementally revert to the Lessor upon the completion of customer transitions. The Parties will file early termination notifications consistent with applicable rules and regulations when this occurs.
