



COMMENTS ON PROPOSED RULE MAKING

These comments are filed in support of the Notice of Proposed Rule Making, MB Docket No. 04-201, RM-10972, by SSR Communications Incorporated ("SSR"), to allot FM Channel 300A to Shorter, Alabama as that community's *first local FM service*.

In the Notice of Proposed Rulemaking, Ms. Rolanda F. Smith asked SSR to resubmit its affidavit indicating that SSR believes its initial petition to be accurate to the best of its knowledge. That affidavit is attached hereto as Exhibit 1.




