Dear Ms. Dortch:

On behalf of Nextel Communications, Inc. ("Nextel"), and in accordance with the instructions contained in the Commission's July 16, 2004 Information Request to Nextel in the above captioned proceeding,¹ we hereby notify the Commission that Nextel has provided to Erin McGrath, Assistant Division Chief of the Mobility Division of the Wireless Telecommunications Bureau, two copies of a CONFIDENTIAL version of Nextel's third response to the July 16 Request, as revised through discussions with Commission staff on July 30, August 18, and September 7, 2004. This production provides electronic versions of (1) spreadsheets previously submitted in hard copy as NEXTEL000016-000064 and (2) spreadsheets previously submitted in hard copy as NEXTEL000001-000002, which have been revised to include rate plan identification codes.

As the Commission contemplated when it issued the Protective Order in this proceeding,² the information contained in this response is both commercially and financially sensitive and concerns proprietary information that neither Nextel nor its subsidiaries would reveal to the public or their competitors in the normal course of business. Under the terms of the Protective
