Dear Ms. Dortch:

On behalf of AT&T Wireless Services, Inc. ("AWS"), transmitted herewith please find an electronic version ("CD") of revised data files requested by Martin Perry.

As the Commission understood when it issued the *Protective Order* in this proceeding,<sup>1</sup> the information contained in the accompanying CD is both commercially and financially sensitive and concerns proprietary information that neither AWS nor its subsidiaries would in the normal course of business reveal to the public or their competitors. 
