Dear Mr. Carlisle:

Attached are 12 signed "Acknowledgement of Confidentiality" forms (Exhibit B to the August 20, 2004 Protective Order) for BellSouth In-House Counsel, in-house paralegals, in-house legal secretaries, and outside consultants and experts retained for the purpose of assisting BellSouth counsel in this proceeding.
