(4) **SLD's Reason for Funding Denial and Hickory's Response:**

Background: Attached is an e-mail that was sent to the SLD's AL Arauz.

While the Hickory School District and the SLD were exchanging voice mails, and e-mails, there was no real communication-taking place. Unfortunately, when this happens and because the burden was on the Applicant, the School District lost its opportunity for badly needed funding. The Hickory City School District is asking the Federal Communications Commission to remand this matter back to the SLD for full consideration. **Exhibit A**

Conclusion:


Hickory is Requesting the Following Action by the FCC:

Today I received a VERY disturbing letter from the USAC stating that they're NOT funding applications:

...because I have yet to respond to their (your) requests for additional information to support our ability to fund our portion of the total funds requested. I assume this is the massive request for information under the "Selective Review" moniker. I have "responded," to the requests (though the letter states I have not), just haven't provided all the requested documentation.

I have sent you a couple of emails the past few weeks, some updating you on my status and some requesting information (electronic version of your original request) to which I have received no responses from you. I thought you may have been out of the office.

In any case, I am still trying to finalize all the information requested of the Selective Review. I could have more easily provided some documentation along the way, but based on last year's experience with the selective review (you were checking for me to see why we were "chosen" two years in a row, since it was a random process), I was waiting until all info was gathered; some of which is not available to me until AFTER the finance department closes the books on this fiscal year and the auditors complete their review. This time "window" happened last year. The information I provided before the close of the fiscal year was, for whatever reason, not acceptable. Only that which was provided AFTER the close of the fiscal year was seemingly accepted (have yet to hear otherwise).

Please let me know that this information is still "submittable" to you for funding consideration.
