Dear Ms. Dortch:

On October 27, 2004, Terry Mackin, Executive Vice President of Hearst-Argyle Television, Inc. and President-Chairman of the NBC Television Affiliates ("NBC Affiliates"), and the undersigned, counsel for NBC Affiliates, met with Jonathan Cody, Legal Advisor to Chairman Powell; with Commissioner Adelstein and his Legal Advisor, Johanna Shelton; and with Elizabeth Andriou, Special Advisor to Commissioner Martin. On October 28, 2004, Mr. Mackin and the undersigned met with Commissioner Abernathy and her Legal Advisor, Stacy Fuller; and with Jordan Goldstein, Senior Legal Advisor to Commissioner Copps.

The purpose of these meetings was to brief the Commission on NBC's and the NBC Affiliates' plans to launch a digital multicast weather channel. The presentation focused on the business aspects of and plans for this channel and its local focus. NBC Affiliates also discussed the importance of a multicast carriage requirement to ensure that consumers will be able to receive this new service as well as other innovative multicast services that local broadcasters would like to deliver to their viewers. In addition, in the meetings with Commissioner Adelstein and Ms. Shelton and with Mr. Goldstein, NBC Affiliates discussed broadcasters' public interest responsibilities and, in particular, the need for flexibility to ensure that any such requirements do not hamper a broadcaster's ability to serve the particular needs of its community and to assure that broadcasters continue to have the freedom necessary to be creative and to provide diverse options to viewers.
