**PLEADING CYCLE ESTABLISHED FOR COMMENTS
ON COX'S PETITION FOR A DECLARATORY RULING, FOR CLARIFICATION OF THE
COMMISSION'S RULES AND POLICIES REGARDING UNBUNDLED ACCESS TO
INCUMBENT LOCAL EXCHANGE CARRIER'S INSIDE WIRE SUBLOOP**

On October 27, 2004, Cox Oklahoma Telecom, L.L.C. (Cox) filed a petition pursuant to section 1.2 of the Commission Rules requesting that the Commission issue a declaratory ruling confirming that:

- (1) competitive LECs have a right to direct physical access to incumbent LECs' inside wire subloops in MTEs;
- (2) this right allows competitive LEC to obtain direct access to inside wire subloops at incumbent LECs' terminal blocks in MTEs; and
- (3) this right exists regardless of any state law or regulation that would otherwise limit the right.

This Public Notice establishes certain procedural requirements relating to consideration of Cox's petition. This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules. See 47 C.F.R. §§ 1.1200, 1.1206. Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required. See 47 C.F.R. § 1.1206(b). Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in Section 1.1206(b) of the Commission's rules, 47 C.F.R. § 1.1206(b).

Pursuant to Section 1.415 and 1.419 of the Commission's rules, 47 C.F.R. §§ 1.415, 1.419, interested parties may file comments on Cox's petitions on or before **December 6, 2004** and reply comments on or before **December 21, 2004**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.

Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appear in the caption of this proceeding, commenters must submit two additional copies for each additional docket or rulemaking number.
